### **A Simple Process**

Buying land should not feel complicated. Our process is designed to be clear and predictable from start to finish.

First, you explore our available properties and contact us with questions about any parcel that interests you. We are happy to discuss access, zoning, general location, and intended use.

Next, you choose how you want to purchase the property. Buyers may pay in full or use owner financing. Financing does not require a credit check and does not include prepayment penalties. Terms vary by property and are explained before any agreement is signed.

Once you decide to move forward, we send you a clear purchase agreement outlining the price, payment structure, and property details. You review and sign electronically at your own pace.

After the agreement is in place, we prepare and handle the required paperwork according to the agreed structure. If financing is used, ownership transfers after the balance is paid in full.

When the final payment is completed, the deed is recorded in your name and delivered to you for your records.

### **How Our Land Sales Work**

### **Available Properties**

Our inventory changes regularly and includes parcels ranging from small lots to larger acreage. Prices typically start around three thousand dollars and increase based on size and location.

We offer a mix of rural land and select lots inside city limits. If you do not see the right property today, new parcels are added regularly.

---

### **Purchase Process**

Once you select a property, you contact us to confirm availability and ask any remaining questions.

You then choose whether to purchase with cash or owner financing. Financing terms vary by property. No credit checks are required, and there are no prepayment penalties. A one time document fee applies.

You receive a purchase agreement outlining the price, payment structure, and property details. After signing, we handle the paperwork according to the agreed structure.

Ownership transfers after the balance is paid in full, at which point the deed is recorded and delivered.

### **Financing Overview**

Owner financing removes the need for a bank and allows buyers to move forward at their own pace.

Buyers make a modest down payment and then complete monthly payments based on the purchase price and term. Terms vary by property.

The balance may be paid off early at any time without penalty. Ownership transfers after full payment is completed.

Buyers are encouraged to visit the property and perform their own due diligence before completing a purchase.
